For each application form. **Students from families receiving CSSA are exempted from application fee.** Please attach a copy of proof when submitting your application. Applicants failed to provide a valid copy of proof on or before the application deadline are not eligible from exception.

Each application has to go through the selection process by the Admission Committee. In addition, courses may be cancelled, thus course offer is not guaranteed. Application fee paid is **NOT refundable and NOT transferrable** under any circumstances. Please note applications without successful payment and without a valid copy of proof of CSSA will NOT be processed.

If you choose to pay by cheque, please prepare a crossed cheque made payable to "The Chinese University of Hong Kong" with applicant's full English name written at the back.

Tuition Fee

Tuition fee for each course varies. Please refer to the *Course Description* in PGT website for details. Tuition fee is payable only when the applicant is successfully admitted after the selection process. Admission Notification will be sent to successful applicants individually.

School Recommendation Form

If you are a new applicant or you have not taken PGT courses before, then you MUST ask your principal, guidance teacher (counselor), class teacher or any teacher, social worker, or educational psychologist in your school who knows you well to complete the *School Recommendation Form* and send it back to us by the referee's school email account on or before the deadline stated in the form. **The Excel form could be downloaded from CUHK PGT website.**

Choice of Course

Applicant can have three choices of course in each application form according to his/her **interest, strength, and current grade level**, and rank order the choices using the **Course Codes**. If successfully admitted, each application form will be offered only **ONE** course among your choices. If you wish to apply for enrolment in more than one course, please submit separate applications.

Selection Test

Applicants have to attend a selection written test in **one of the sessions** assigned by PGT. Date of selection test is printed on page one of the application form. All applicants will be notified of their selection test details by email. **If the applicant has NOT received the Selection Test Notification by the specified date**, please contact PGT. Absence from the selection test without prior notice to PGT will be considered **as withdrawal from application** (application fee is non-refundable).

Admission Result

Each application will be examined carefully by the PGT Selection Committee. Selection for admission is based on the applicant's performance in the PGT selection test, his/her school performance, school recommendation, evidence demonstrating the applicant's talents and potential provided (such as awards, prizes, other recognitions or IQ assessment reports), and the courses and/or workshops applied. Application results will be announced on the PGT website. Applicants will also be individually notified of their application results via email.

Applicants are advised to provide all the information requested. Applicants have to submit all required documents, application fee, and provide all the information required on or before the deadline. The Selection Committee will not be able to process your application if you fail to do so.

Financial Assistance for Students

Financial assistance is open for application to students whose families **have financial difficulties**. Parent / guardian should fill in the related section in the application form if the applicant would like to for financial assistance. PGT will not consider the financial assistance application if we do not receive any valid proof of financial support on or before the application deadline.
