## 教育博十學位課程

# **Doctor of Education (D.Ed) Degree Programme**

課程總監 Programme Director: 謝志成教授 Prof. TSE Chi Shing

本院於 1997 年開辦全港首個教育博士學位課程,首屆學員於 2001 年畢業。課程自開辦以來,吸引了多個界別的人士報讀,包括中小學及大專院校的資深專業工作者、政府官員及從事社會服務工作的人十等。

教育博士學位課程兼重修課與研究,提供多類科目選擇,並要求學員在導師指導下進行論文研究,旨在讓學員對專研範圍有深入的認識,鼓勵學員以創新方法進行教育探究,並培養學員對解決教育問題的洞察力。

此外·本課程冀能令教育專業人士對專研範圍有更堅實的理論和實踐基礎·並在此基礎上有效面對教育改革的挑戰。

Our Doctor of Education programme, offered since 1997, was the first of its kind in Hong Kong. It graduated its first group of students in 2001. The Doctor of Education programme is a professional doctorate that includes both coursework and research components. It offers a variety of relevant courses and supervised thesis research. The Doctor of Education programme aims to help experienced professionals to develop a deep understanding of their chosen areas of study, to encourage them in the search for innovative approaches to educational inquiry and practical insights, and to assist them in resolving educational problems.

The Doctor of Education programme is designed to suit the needs of professionals who seek to meet the challenges of educational change effectively and desire to have their work thoroughly grounded in the theory and practice of defined areas of study. Over the years, the majority of students admitted by the programme are school principals, senior teachers, lecturers and administrative staff in universities, and other professionals working for government agencies and social organisations. Their thesis studies have produced valuable indigenous knowledge to inform educational decisions and improve educational practices. The doctoral graduates are an important driving force in serving and leading our local / regional educational community.

- (b) PEDU8000 is a thesis monitoring course. Students are required to take PEDU8000 every term from the time of admission, throughout the preparation of thesis, until its completion.
- (2) Qualifying Examination

### Applicable to students admitted in 2023-24 and thereafter

Advancement to Doctor of Education candidature is conditional upon the satisfactory completion of the followings:

- a. 21 units of coursework requirement, and
- b. presentation and passing of thesis proposal (PEDU8010) within 18 months after the completion of coursework requirement.

No further qualifying examination is required.

#### Applicable to students admitted in 2022-23 and before

Advancement to Doctor of Education candidature is conditional upon the satisfactory completion of the 21 units of coursework. No further qualifying examination is required.

#### (3) Other Requirements

#### Applicable to students admitted in 2023-24 and thereafter

- a. Students must fulfill the Term Assessment Requirement of the Graduate School. - b. A student must achieve a cumulative grade point average (GPA) of at least 2.0 in order to fulfil the graduation requirement.
- c. Students who fail in thesis monitoring course shall be put on academic probation. Students shall be required to discontinue studies unless 13.3 of General Regulations Governing Postgraduate Studies applies.
- d. Attending PhD Programme Annual Seminars / Doctoral Thesis Proposal Presentations (Applicable to students admitted in 2015-16 and thereafter)
  Full-time students are required to attend not less than 15 sessions of PhD Programme annual seminar / doctoral thesis proposal presentation during normative study period. Part-time students are required to attend 4 sessions of PhD Programme annual seminar / doctoral thesis proposal presentation each academic year after advancement to candidature
- e. Within 18 months after the completion of coursework requirement, the student has to register for the course PEDU8010 (9 units), and to present and pass the thesis proposal in an open presentation. After the thesis proposal has been approved, the student will be granted Doctor of Education candidature. The candidate, under the supervision of her/his supervisor, should submit a thesis and pass the oral examination within a prescribed period of time for graduation. Should the student fail to obtain candidature within 18 months after completion of coursework, the student may seek approval for further extension of 6 months with solid justification. Students who fail to advance to candidature within the extended period will be required to discontinue studies, unless special approval is granted by the Faculty Board.
- f. Students are required to complete an Improving Postgraduate Learning (IPL) module on "Observing Intellectual Property and Copyright Law during Research". This is an online module and relevant information can be accessed from the website: http://www.cuhk.edu.hk/clear/prodev/ipl.html.
- g. Students are required to complete and pass an IPL module on "Basics of Research Data Management" in their first year of study for completion of the University-specified requirement, with effect from the 2022-23 intake. - h. Part-time students are required to attend 4 sessions of PhD Programme annual seminar / doctoral thesis proposal presentation each academic year after advancement to candidature.
- e. Normally within a year after advancement to Doctor of Education candidature, the candidate has to register for the course PEDU8010 (9 units), and to submit and present the thesis proposal in an open presentation. After the thesis proposal has been approved, the candidate should, under the supervision of her / his supervisor, submit a thesis and pass the oral examination within a prescribed period of time for graduation.
- f. Complete an Improving Postgraduate Learning (IPL) module on "Observing Intellectual Property and Copyright Law during Research".
